

TACLOBAN CITY- The Commission on Elections (Comelec) here in the region continues its preparations for the barangay and Sangguniang Kabataan (SK) polls amid moves to cancel the elections until next year by several lawmakers and even local officials.

In fact, they are now in the midst of preparing the list of registered voters for the said balloting, Jenette Fariola Ruedas, the information officer of the Comelec-8, said.

She said that the posting of the final list of registered voters will be on September 6.

"The Commission on Elections continues its preparations for the barangay and SK elections while there is no law yet on the postponement. We hope that the decision will be out the soonest," Ruedas said.

It was learned from her that during the registration

conducted by the Comelec last July, more than 253,000 prospective voters from various parts of the region have enlisted themselves.

The barangay and SK polls will be conducted manually and not electronically compared to the national balloting like the May 9,2022 presidential elections.

Several lawmakers and even local officials are calling for the cancellation of the barangay and SK polls originally slated this December 5.

Mayor Rosales won over 1,000 votes against his rival Court dismisses poll protest against Catarman mayor

CATARMAN, North- missed the petition of Lope Dorado ern Samar- A regional trial court here has dismissed the election protest against Mayor Aurelio Rosales III filed by his losing opponent which questioned the validity of his proclamation as the duly-elected mayor of this town during the May 9, 2022 elections.

In the eleven-page decision, Judge Armando Rosadiño, the presiding officer of RTC-branch 20, disto declare as invalid the proclamation of Rosales as the duly elected mayor of the provincial capital of the province.

"The court hereby renders judgment, dismissing the election protest and declaring as valid the proclamation of Rosales as the duly elected municipal mayor of Catarman," the court said.


Dorado, who gained 22,863 total votes, lost to Rosales who garnered 24,811 votes during the recently-held balloting.

But in his protest, Dorado alleged "several irregularities and massive substitution" in the clustered precincts in five barangays - Polangi, Cag-abaca, Macagtas, General Malvar, and Imelda - citing that the voters counting machines (VCMs) did not count some of the votes for him and were counted instead to Rosales.

Dorado then requested the court to review the ballots in the said clustered precincts and see Court /page 7

U.S. partners with DepEd to design learning spaces for the future

Manila-The United States government, through the U.S. Agency for International Development (USAID), trained over 50 officials from the Department of Education's (DepEd) central, regional, and division offices in designing and developing prototype learning spaces to address future challenges in the education sector during a workshop held from August 15 to 19.

"As our teachers and learners continue to face barriers to equitable and inclusive education, we must continuously explore ways to ensure that all have access to quality teaching and learning resources by sustaining gains in education technology and by supporting and enhancing teachers' leadership roles," USAID Philippines Education Director Dr. Thomas LeBlanc said.

The five-day workshop, organized in partnership with DepEd, was designed to help education personnel develop solutions for learning spaces that are contextualized and adaptable to address future challenges in education. Participants learned to carefully define issues to be addressed, empathize with teachers and learners, and conceptualize, design, and test a prototype learning space that addresses education-related needs.

To illustrate the outcomes of the workshop, the Schools Division Office of Tanauan, Batangas sought to address the issue of crowded classrooms by designing an interactive gazebo that enables students to explore nature while developing important technological and social skills.

DepEd Region 7 Assistant Regional Director Cristito Eco challenged participants to focus on innovative solutions. "When faced with problems or issues, do not think immediately of the cost. Think of possible solutions and your stakeholders," he said. "This futures thinking workshop helped us appreciate our partners in creating solutions together."

The United States government has been a key development champion in the Philippines for over 60 years, working with individuals, communities, and the government to improve everyday lives. Through its All Children Reading Philippines project, USAID aims to support DepEd in improving early grade reading skills for 100 million children. (**PR**)

GOVERNMENT CEN-TER, PALO, Leyte- The Tacloban City causeway, tagged as one of the priority infrastructure projects here in Eastern Visayas, will soon be implemented by the Department of Public Works and Highways (DPWH) Region 8 before the year ends.

First of its kind here in Region 8, the Tacloban City Causeway has a total project cost of P3.4692 billion and will be constructed over the Cancabato Bay connecting Tacloban City Hall area to Kataisan Point of the Daniel Z. Romualdez Airport area in Barangay San Jose, Tacloban City.

This will serve as an alternate route for motorists from the city proper going to the airport, offering reduced travel distance, travel time, vehicle operation costs, and road accidents.

"Our Planning and Design Division (PDD) figures that the travel time using the original route usually takes up to 45 minutes, but traversing through this causeway, travel time will approximately take up to 10 minutes only," Regional Director Allan S. Borromeo

said. This causeway which is a 4-lane road embankment spans approximately up to 2.557-kilometer in length with a bridge that stretches to 180 meters.

This project also has separate bike lanes, concrete canals, sidewalks, as well as wave deflectors on both sides.

RD Borromeo relayed that per project design, the alignment starts at Magsaysay Boulevard with elevation gradually increasing towards the bridge at the middle part of the causeway, as required for navigational clearance, and eventually slopes down towards the end of the alignment.

"This project is expected to offer an improved path user experience that attracts the local community and tourists, and will soon cater as an infrastructure that can be used by motorists seeking for a scenic drive, and by locals who prefer walking, running, and biking," RD Borromeo said.

The official also added that the causeway project is designed to be sturdy see Tacloban /page 7 .

Maasin city gov't puts ceiling prices on pork and other meat products

TACLOBAN CITY -The city mayor of Maasin has signed and issued an executive order an order re-adjusting the selling price ceiling for pork and other meat products and buying price ceiling for live hogs.

The order, as contained under Executive Order 34, took effect last Thursday (September 1).

The price adjustment of pork and meat products was issued after supply in the city improved after they were hit by the African Swine Fever (ASF) early this year.

"It has reached to the attention and observation that there is now (an) improvement in the supply of hogs compared to past months, due to the entry of other traders or hog raisers from Hinunangan, Tacloban, and Cebu City resulting to the reduction in the buying price of live

hogs," Mayor Nacional the city. Mercado said in his order.

The new selling price of pork meat products in Maasin City cost P330 for regular meat from the previous P350; boneless pork is now at P340 from P360; meat roll, P350 from P370; pork leg, P230 from P250; pork liver, P230 from P250; and pork mascara, P220 from P240; while pork intestine, empelya, and bogs will remain P110 per kilo, and live pigs will cost P200 to P215 per kilo from P215 to P225.

For a live sow ('anay') buying price will be P100 per kilo while its regular meat price is P220; boneless is P240; meat roll, P250; feet P100; liver,

this time, classes are supposedly in full swing from elementary to college levels and, so far, things are going fine as regards the observance of health protocols imposed by the authorities—students and teachers come to school with their face masks on, some with health kits, and are compliant with what the school administrations prescribe.

To some students, reminders to observe health protocols are no longer necessary since they have already gotten used to them. They don't need to be told since they themselves are protective of their bodies against illnesses, particularly the COVID-19 virus. Moreover, their parents do not fail to urge them to follow the necessary, safety guidelines.

It seems that, though this pandemic may already be gone, the wearing of face masks would likely continue. It is because some people no longer trust the air in public places. The suspicion is there, especially since one does not know the whereabouts of people nearby. They may have been to other countries with high cases of virus infection, and are come to spread the same unknowingly.

In Cebu, the wearing of face masks is no longer mandatory starting September 1 of this year. But despite the lifting of this mandate of facemask wearing, many are still putting on masks, not to defy the easing up order obviously, but to protect themselves from the fact that the pandemic is still going on. And there is no prohibition on wearing facemasks if people so desire.

Surely, it is to people's advantage if they keep on wearing facemasks in public places knowing that viruses nowadays have become unpredictable. We don't know where and when they strike. And so, on school campuses now, the order to observe health protocols remains in place, for the safety and security of our campus figures.

Some say it's wrong

based on some theoretical assumptions. But I'm not fully convinced because theories are nothing but claims—there is no finality with them; they have yet to be proven. Accordingly, learning is not effective when it's just readily and freely provided. Learners have to discover things themselves for learning to last and work best.


Well, let's put it this way. Let's imagine that learning is eating. And one is supposed to eat a banana in two ways: getting it from me readily, or trying to find a banana stalk to plant and wait for the fruit to come. Now, after eating those bananas one taken with ease, and the other necessitating hard work and discovery—how would the person feel? Satisfied with his craving for bananas, right?

Now, why make that banana acquisition hard when it could be had simply, and easily, without wasting one's precious time? The satisfaction is the same, and the digestion time would likewise last similarly.

Call it spoon-feeding, but I never buy the idea of making simple things difficult and complicated for learners. I'm not that sadistic to do that. In fact, when it comes to in-depth ideas, I really strive hard to simplify them for learners. I feel that it's my duty to do so. I'm a teacher, an educator, and as such, that's exactly what I should do.

I don't call it spoon-feeding; I call it knowledge transfer. This knowledge transmission is not just limited to telling; I employ certain strategies to get ideas across to learners. It could be through

TO be consistent to our Christian identity and vocation, we need to live a certain type of detachment that involves a certain self-emptying that would fill us completely with the spirit of Christ. That's because in the end what truly matters in our life is that we be so identified with Christ that we can rightly be called "another Christ."

Christ said this clearly. "If anyone comes to me without hating his father and mother, wife and children, brothers and sisters, and even his own life, he cannot be my disciple." (Lk 14,25)

Yes, it's a detachment that goes all the way to even be willing to lose our life. Such detachment can only show how much we believe, love and follow Christ. Indeed, it's a tremendous, hard, if not impossible requirement to fulfill, but, for sure, if Christ could do it himself, we too could also do it as long as we believe, love and follow him fully.

Obviously, to abide by that standard we need to go through a long, if not life-long process of developing that spirit of detachment. It's not going to be easy, but let's be convinced beyond doubt that this is what is needed by us and that Christ will always be there to help us.


And we should never be afraid or hesitant to live such detachment, because as Christ himself assured us in another occasion, we should be seeking first the Kingdom of God and his righteousness, and all the other concerns and necessities we have will be taken care of. (cfr. Mt 6,33)

As we can see, what is needed here first is a strong and working faith,

which is actually a gift God gives us but to which we have to correspond as fully as possible. With that faith, we know that what is impossible with us is always possible with God.

Such faith would enable us to echo Christ's words: "Father, if it is possible, let this cup pass from me, but not as I will, but as you will." (Mt 26,39) And while hanging on the cross, he at first complained, "My God, my God, what have you forsaken me." (Mt 27,46) But later on, he rectified by saying, "Father, into your hands I commit my spirit." (Lk23,46)

RTL's excess P8 B tariff revenues released for farmers subsidy

That the Rice Tarification Law (RTL) Is at work, has been proven with the Fund (RCEF) annually to recent release by the Department of Budget and Management (DBM) of P8.05 billion in excess tariff revenues to the Department of Agriculture (DA), as stipulated.

The recipients are some 1.56 million rice farmers found eligible to receive P5K each within the second half of 2022. In 2021, the government secured P18.9 billion from the RTL.

The gridlock in our traffic and the crowding of our schools, classrooms, and shortages of our educational resources are tell-tale signs of deeper problems inside our educational crevices. These, in turn, are manifested in our results on our International Standards Tests and Assessments, and sadly these define us. It also describes us and creates prestige or delineates us from the community from the international learning community.

For a thing or a phenomenon with which we are all too familiar, we must set aside our differences, party affiliations, and interests and solve the problems of our education sector. The traffic on our roads and the overcrowding of our school obvious and perceivable before our very eyes is at the very least something that we all must address. And that we must get our acts together for our children and their future.

Suspect in the killing of a village chairman arrested for illegal possession of firearms

ORMOC CITY- An enlisted member of the Philippine Army suspected to be behind on the shooting to death of a village chief in Javier, Levte last week was arrested by the town police for illegal possession of firearms in Tacloban City last Monday (August 29).

Javier chief of police, Lt. Nicky Bermudo, identified the suspect as Alexandro Calda, 33, enlisted personnel with a rank of a sergeant and assigned at the 63lB based in Basey, Samar.





Construction worker shot dead by two unidentified suspects in Calbayog City

ORMOC CITY-A construction worker died on the spot after two still unidentified gunmen shot him at the back of his head while walking on the way to work about 6: 40 am last Monday(August 29) at Purok 5, Brgy. East Awang, Calbayog City.

Calbayog chief of police Lt. Col Ericson Del Rosario identified the victim as Roy Wahingon, 33, and a resident of P-5 Brgy. West Awang of the said city.

Initial investigation conducted by responding police disclosed that while the victim was walking along the street towards his work place together with his foreman Gregorio Baldomaro, the two armed suspects suddenly appeared from behind and without provocation, shot the victim once hitting on his left head that resulted to his instantaneous death.



TACLOBAN CITY - The Department of the Interior and Local Government (DILG) in Eastern Visayas (Region 8) will hold a regional forum to harmonize devolution transition plans between national government agencies (NGAs) and local government units (LGUs) regarding the implementation of Mandanas-Garcia Supreme Court ruling.

Melford Maderazo, DILG Region 8 focal person of the devolution transition plan (DTP), said they have been doing coaching activities to review correct, and complete the local governments' DTP in the region in preparation for the upcoming forum.

"All cities, towns, and villages have already submitted their DTPs. The next step is to clean up the DTPs in support of the ongoing transition to full devolution," Maderazo said in a press briefing on Thursday.

The DILG has not yet announced the dates of the regional forum that will be held before the end of September.

On the part of the national government, Department of Budget and Management Region 8 assistant director Aleli Hernandez said some agencies in the region have already submitted their DTPs to the DBM central office.

Among these agencies are DILG; Department of Public Works and Highways; Department of Tourism; National Irrigation Administration; Department of Transportation; Department of Science and Technology; Department of Agriculture; Department of Human Settlements and Urban Development; Department of Trade and Industry; Department of Social Welfare and Development; Department of Education; and Office of the Presidential Adviser on Peace, Reconciliation and Unity. "Preparation of transition plans is in close coordination with national government agencies. The plans will serve as guides on the monitoring and performance assessment of local governments by the agencies concerned," Hernandez said.

Government agencies are given until October 2022 to finalize their transition plans.

Executive Order No. 138 and its Implementing Rules and Regulations mandate all provinces, cities, municipalities, and villages to prepare their DTPs in close coordination with the concerned national government agencies to guide them towards the full assumption of devolved functions and services that come with more financial resources.

Last year, then President Rodrigo Duterte issued the directive to boost the local government's preparation for more responsibilities with the implementation of the Mandanas-Garcia ruling in 2022.

The Supreme Court Mandanas-Garcia ruling resulted from the petition made by Batangas Governor Hermilando Mandanas and former Bataan governor Enrique Garcia Jr. before the Supreme Court on local government shares on internal revenue allotment (IRA).

With the increased budget share, the LGUs are expected to be responsible for the funding and delivery of the activities, which have been devolved to them under Republic Act 7160, the Local Government Code of 1991, and other subsequent laws.

Among the functions assigned to local governments based on the Local Government Code are agriculture programs, local infrastructures, environmental services, revenue mobilization, health services, maintenance of peace and order, employment facilitation, transportation, tourism, and housing. (PNA)


